**Wedlake Bell successfully advises Verditek Plc on its admission to the  
Alternative Investment Market (“AIM”)**

London law firm Wedlake Bell LLP has advised Verditek Plc (“Verditek”) on its admission to AIM, a market regulated by the London Stock Exchange (“LSE”). The trading of Verditek’s shares started at 8 am today, under the ticker “VDTK” and ISIN number of GB00BF2C0424.

The Company, via three clean technology businesses, is focused on what it considers to be emergent and fast-growing clean technology sectors including, but not limited to, next generation solar panel technology, liquid gas absorption for CO<sub>2</sub> capture and emission control and a filtration system which de-odourises air in waste water treatment systems. The admission to AIM is part of Verditek’s ongoing growth strategy.

Wedlake Bell advised on Verditek’s cross-border acquisition of the controlling stakes in the three named companies operating in the clean technology sector. The firm was also instructed on Verditek’s subsequent initial public offering (“IPO”) on AIM and the placing of and subscription for new shares in the company raising £2.75 million (gross). The legal team was led by Janice Wall, Head of Wedlake Bell’s Corporate Business Group and Adam Edwards, Partner and Head of IT Law with the assistance of Kamalprit Lally, Corporate Associate. Stockdale Securities Limited acted as Nominated Adviser and Broker to Verditek.
