SRA DIVERSITY SURVEY 2023

INTRODUCTION

As part of the Solicitors Regulation Authority's (SRA) drive to promote equal opportunity and diversity at work, all legal firms are required to collect and report diversity data from their own workforce every two years.

In June 2023, we collected data from Wedlake Bell partners and employees using the anonymous survey prescribed by the SRA.

We encouraged all our firm members to take part in the survey, however, completion was voluntary, and some employees preferred not to take part.

We achieved a response rate of 81%. The results in this report are representative of those who responded to the survey.

The role categories have been grouped in the following way:

Partners

Solicitor – excludes all Partners, includes all other qualified Solicitors, including Professional Support Lawyers.

Other Fee Earners - includes all other non-qualified (via SRA) fee earning roles e.g. Trainees, Paralegals, Chartered Legal Executives.

Business Support - includes all working in business services roles, e.g. HR, Finance, Compliance, BD, IT, Secretarial.
